Privacy

This privacy statement describes how MPower collects and uses the personal information you provide. It also describes the choices available to you regarding our use of your personal information and how you can access and update this information.

Location Services

We do not request, collect, or access your location information.

Collection and Use

We collect the following personal information from you:

- Contact Information such as name, email address, mailing address, phone number
- Unique Identifiers such as user name, account number, password
- Preferences Information you provide such as product or content interests, or communication or marketing preferences.
- Usage activity about how you interact with us such as purchase history, what content you viewed, and which areas of our site you visited.
- Device Information

As is true of most Web sites, we automatically gather information about your computer such as your IP address, browser type, referring/exit pages, and operating system.

We use this information to:

- Send product updates or warranty information
- Send you push notifications when you are using our app. If you do not want these notifications, you can manage your preference either through your device or app settings

- Display content based upon your interests
- You may sign in using your OpenID. This ID may be tied to your mobile phone number to verify you have access to the mobile device. Your sign-in credentials are used to sign you into your account.

Sharing Your Information

We will share your information with third parties only in the ways that are described in this privacy statement.

We may disclose your personal information

- as required by law, such as to comply with a subpoena, or similar legal process.
- when we believe in good faith that disclosure is necessary to protect our rights, protect your safety or the safety of others, investigate fraud, or respond to a government request.
- if MPower is involved in a merger, acquisition, or sale of all or a portion of its assets, you will be notified via email and/or a prominent notice on our Web site of any change in ownership or uses of your personal information, as well as any choices you may have regarding your personal information.
- to any other third party with your prior consent to do so.

Security
